The merchandise load-in will be Friday from 12-7 pm, unless alternate arrangements are made by the Gun Show Director. Since you were an exhibitor at previous year's gun shows, you can reserve the same number of tables that you had at last year's show, location may vary, but we will try to provide the same table(s) as the last gun show. If you are interested in reserving the table(s) you had at the 2024-gun show, **PLEASE RETURN THE BOTTOM PORTION OF THIS LETTER AND THE GUNSHOW RULES PAGE WITH YOUR CHECK BY DECEMBER 1, 2024. I CANNOT GUARANTEE A TABLE FOR YOU AFTER THIS DATE AND IT MAY BE REASSIGNED TO ANOTHER VENDOR. I will start calling vendors that are on our standby listing on 1 December.**

We require every vendor to verify that all firearms purchasers are of legal age by requiring the purchaser to produce a valid picture Identification (ID) before the sale and meets all applicable laws. If you feel that you cannot agree to this requirement, you will not be able to exhibit at our show.

## ■ ANNUAL GUNSHOW VENDOR/EXHIBITORS RULES

Every item on this document needs to be initialed and then needs to be signed and dated. Without initials and signatures/date your table(s) reservation will not be considered. Failure to properly initial and sign/date this document by the prescribed deadline will result in the vendor losing their requested tables and being moved to the standby list. **Flip over to sign and date.**

| <b><u>I understand I have until December 1, 2024, to reply and make payment for reservation of tables. This 2025 gun-show will be held on Jan 25-26.</u></b>  |                             |
| <b><u>I UNDERSTAND ALL REGISTRATION FORMS RECEIVED ARE TO BE RETAINED BY THE GUN SHOW DIRECTOR.</u></b>   |                             |
| I understand ALL firearms brought into the gun show by the public, excluding concealed carry gun(s), shall be unloaded, actions open and strapped. Firearms must be marked with an appropriate label at the door.   |                             |
| I will follow all Local, State, and Federal Laws and Regulations at all times.  |                             |
| I understand that alcohol is absolutely prohibited.   |                             |
| I understand that display and storage of black powder is prohibited.  |                             |
| I understand that displaying or storing more than five (5) pounds of Pyrodex is prohibited.   |                             |
| I understand that loaded firearms, magazines or clips are prohibited on CRPC premises unless covered by a valid, Wyoming concealed carry permit.  |                             |
| I understand that I am required to keep all guns unloaded and tied in a manner to prevent firing, including removal of the magazines.   |                             |
| I understand firing firearms on the premises is prohibited.   |                             |
| I understand that all ammunition must be packaged, preferably in factory packaging.   |                             |
| I understand that gunsmith and reloading work are prohibited during the show.   |                             |
| I understand that the display or sales of illegal firearms or ammunition are prohibited.  |                             |
| I understand all firearms and merchandise I sell shall be marked with an appropriate label.   |                             |
| I understand that all gun actions, on all guns sold, shall be zip tied before the gun(s) leaves the exhibitor's table.  |                             |
| I understand NO one, exhibitors or public, may be allowed to leave the premises by the back doors, during the hours the gun show is open.   |                             |
| I understand exhibitors shall be able to leave at the discretion of the Director, if they show extenuating circumstances and have contacted the Director before noon on Sunday.   |                             |
| I understand exhibitors shall check in and move into the range all items they will be selling on their tables between the hours of 12-7 p.m. on Friday afternoon ahead of the show.   |                             |
| I understand exhibitors shall not sublet their tables to another party unless it has been cleared by the director at the time of application for a space at the gun show.   |                             |
| I understand the Director enforces the Gun Show Rules and makes sure that the CPRC's insurance requirements are met.  |                             |
| I understand that, if a firearm is carried concealed, it shall remain in its holster at all times.  |                             |
| I understand that the Director may ask me to remove items from my table. If directed to removed items the table, I understand that the item must be removed from the building immediately. Items that are subject to removal are: <ul style="list-style-type: none"> <li>a. Any products, literature, or signs which, in the Directors or CRPC Board's opinion, is</li> </ul> |                             |

offensive.

- b. Any counterfeit items which are not clearly marked as fake, with an attached label (counterfeit goods are fake products that are made of cheaper materials and are of substandard quality that are being sold under the name and trademark of another brand without the authorization from the brand owner).
